Order for Correction
of Decree

Now on this 29th day of August, 1933, the above entitled matter coming on to be heard on motion of Lulu H. Pierce and Ruby M. Erkenbrecker for the entry of an order correcting certain errors and omissions in the decree heretofore entered herein by the Court, and

It appearing to the Court from the motion of the petitioners and from the affidavit of L. B. Hayes attached thereto that the total acreage to which rights were decreed amounted to 195 acres whereas the distributed acreages total but 165 acres; and it further appearing that the decree shows 55 acres irrigated in NE $\frac{1}{4}$ SW $\frac{1}{4}$ which could not be correct; and it further appearing from said motion and affidavit that certain lands which are irrigated have not been mentioned in the decree whereas some lands are mentioned which are not actually irrigated, and

It further appearing that the rights of no persons other than the petitioners are involved and that no change in the point of diversion of the decreed waters is involved, now therefore,

IT IS CONSIDERED, ORDERED AND DECREED That the decree in the above entitled matter, insofar as it affects the lands of Ruby M. Erkenbrecker and Lulu H. Pierce be corrected to read as follows:


